### Personal data processed by Burgemeester Vastgoed

Burgemeester Vastgoed processes your personal data because you make use of the services of Burgemeester Vastgoed and/or because you choose to provide these data to us. Please find below a list of the personal data we process:

- First and last name
- Gender
- Date of birth
- Place of birth
- Address details
- Telephone number
- Email address
- Bank account number
- All other personal data that you have provided us with or that we can obtain in connection with the purposes and on the basis of the principles that are stated below
- Copy ID

### Special categories of personal data and/or sensitive personal data processed by Burgemeester Vastgoed

Burgemeester Vastgoed processes special categories and/or sensitive personal data of you insofar as provided by you. This may include information about:

- Dutch citizen service number (“BSN”)
- Copy ID

We collect this personal data because you have provided it to us. For example: you provide data when entering into an agreement with us, by entering your details on our website or by giving us your business card. We may also obtain your personal data from other sources, such as a business relationship, the Trade Register (*Handelsregister*), the Land Registry (*Kadaster*) or by using public sources.

## The purpose and legitimate basis of the processing of personal data by Burgemeester Vastgoed

Burgemeester Vastgoed processes personal data for the following purposes:

- To be able to deliver our services to you.
- The handling of your payments.
- To send our newsletter and/or advertising brochure.
- To be able to call or email you when necessary in order to be able to perform our services.
- To inform you about changes to the services and products of Burgemeester Vastgoed.
- For the execution of the agreement between you and Burgemeester Vastgoed.
- In cases Burgemeester Vastgoed is required to do so by law such as data needed for its tax returns.
- We use Google Analytics on our website to provide personalized services

Burgemeester Vastgoed processes your personal data on the basis of one or more of the following legal principles:

- The execution of an agreement;
- In order to comply with a legal obligation;
- Legitimate interest;
- Your permission.

## Automated decision-making

Burgemeester Vastgoed does not take decisions based on automated processing on matters that may have (considerable) impact on people. These are decisions taken by computer programs or systems without any human interference (for example automated refusal of an online credit application).

## Retention period

Burgemeester Vastgoed stores your personal data no longer than strictly necessary to achieve the goals for which your data is collected or to comply with applicable laws and regulations. Burgemeester Vastgoed applies the following retention periods for the following (categories of) personal data:

## Sharing or personal data with third parties

Burgemeester Vastgoed will not sell your data to third parties and will only share this information if this is necessary for the execution of the agreement, for example with a civil law notary, or if required by law. Burgemeester Vastgoed enters into data processing agreements with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Burgemeester Vastgoed remains responsible for this processing.

## Cookies and similar techniques

Burgemeester Vastgoed uses cookies on its website. A cookie is a simple text file that is stored on your computer by a web browser. We use these cookies to facilitate logging into our website and to remember your settings and preferences. You may refuse the use of cookies by selecting the appropriate settings on your web browser. Please note that this may affect the functionality of the website. The website does not use any tracking cookies or advertising cookies. The following functional and analytical cookies may be placed via the website without your prior consent:

## Accessing, rectifying or deleting of personal data

You have the right to access your personal data, to rectify these and to delete these. Besides, you have the right to withdraw the consent you previously have given or to object to the processing of your personal data by Burgemeester Vastgoed. You have the right to data portability. This means that you can submit a request to transfer the personal data we have of you in a computer file to you or to another organisation. To ensure that the request for access is done by you, you will have to enclose a copy of your identification with the request. Please black out your photo, the machine readable zone (the strip with number at the bottom of the passport), your passport number as well as your Dutch citizen services number (or social security number). This is to protect your privacy. Burgemeester Vastgoed will respond as quickly as possible to your request, in any event within four weeks. Burgemeester Vastgoed points out that you have the possibility to file a complaint with the national regulator, the *Autoriteit Persoonsgegevens*.
